

# **IMPORTANT FALL TERM 2017 DATES**

**FOR STUDENTS RECEIVING VA EDUCATIONAL BENEFITS AT CHEMEKETA COMMUNITY COLLEGE**

**Veteran registration began.....Tuesday, MAY 22**  
Students in a mandatory advising cohort must meet with their advisor before they can register.

**Earliest fall term benefit requests will be submitted to VA.....Monday, AUG 28**  
Students must have completed class registration before submitting their fall term benefit request.

**Ch31 fall term Bookstore purchase authorizations will be available at the Veterans' Services Window beginning.....Tuesday, AUG 29**

**Fall term classes begin.....Monday, SEP 25**

**Last day to drop a regularly scheduled 11 week FALL term course and receive a tuition & fee refund.....Friday, OCT 6**  
See the printed current term schedule for additional information about Chemeketa's refund policies for the two 5 week terms.

**Last day for Veterans to drop a regularly scheduled 11 week class without the VA creating an overpayment of benefits.....TUESDAY, OCT 24**  
The last day to drop a class during the 5 week term that begins Oct 31<sup>st</sup> is Nov 13<sup>th</sup>. All reductions changing benefit status are reported to the VA. The VA will review all reported changes to a students' status and notify the student if an overpayment of benefits has occurred.

**Last date to drop an 11 week class without responsibility for a grade..... Friday, NOV 3**  
See the current term schedule for information about the 5 week terms that begin Sep 29<sup>th</sup> and Nov 2<sup>nd</sup>.

**LAST DATE TO REQUEST ADVANCE PAY FOR WINTER TERM 2018.....Friday, OCT 27**  
Only students receiving Chapter 30, Chapter 1606, & Chapter 35 benefits may request an advance. Students are eligible to request an advance benefit payment if they are requesting benefits for the first time at Chemeketa or if they have not used benefits for at least one full term prior to the term of the request. Students requesting advance payments must come to the Salem campus to sign for receipt of their check and verify that all courses they have registered for are eligible for VA educational benefits. Requesting an advance does not guarantee VA will issue the check before the term begins.
