I. INFORMATION

ASC Legislative Internship Program

Peter Wirfs discussed the legislative internship program that was launched last fall. There were four student interns who were placed with two senators and two representatives, and the legislators had positive things to say about the interns and would like to work with Chemeketa in the future. Yajaira Milian-Vargas spoke about her experience as a legislative intern with Representative Tom Andersen's office.

Annual Evaluation of the President

Ron Pittman reported that the board conducted the annual evaluation of the president. Ken Hector read the evaluation statement. Jessica Howard was reviewed on the following categories: Board of Education; Management Competencies; Communicates Effectively; Facilitates Team Success; Community; Educational Planning and Leadership; Business, Finance and Facilities; and College Personnel. In addition, Jessica asked for feedback on her performance related to the annual key college initiatives. The board rated Jessica's performance as exceptional in the categories listed above.

Suspension of Computer Information Systems Certificates of Completion: Systems Administrator and Network Security, Computer Programming, and Web Developer Certificates of Completion

R. Taylor, Executive Director, CCBI, Business Programming, and Early Childhood Education, noted these certificates do not stand on their own and asked for the certificates to be suspended. She indicated that the college is working with partners across the state to develop certificates that would stand alone as an entry-level certificate into the field. Suspension of Corrections Associate of Applied Science Degree and New Corrections Associate of Applied Science Degree

Megan Gonzalez, Criminal Justice Program Chair, noted that there were different changes to the courses within the Corrections Associate of Applied Science degree program. Since the number of required credits was changed, the degree had to be suspended and a new one created under the Northwest Commission on Colleges and Universities (NWCCU) regulations. The board will be asked to approve at the next board meeting.

Suspension of Law Enforcement Associate of Applied Science Degree and New Law Enforcement Associate of Applied Science Degree

Megan Gonzalez noted that there were different changes to the courses within the Law Enforcement Associate of Applied Science degree program. Since the number of required credits was changed, the degree had to be suspended and a new one created under NWCCU regulations. The board will be asked to approve at the next board meeting.

Human Services Program and Degree Changes

Shaunah Steele, Director of Behavioral Health and Health Promotion, stated they are changing the program name to Behavioral Health and all of the prefixes of the courses from Human Services to Behavioral Health, and moving three Associate of Applied Science degrees (Addiction Studies, Social Services and Direct Support Professional) into one degree: Behavioral Health Associate of Applied Science degree. The revised program fills workforce gaps on state and national levels. The board will be asked to approve at the next board meeting.

Medical Assisting Associate of Applied Science Degree

Paul Davis, Dean of Yamhill Valley Career and Technical Education and Wine Studies, noted Chemeketa has a Medical Assisting Certificate of Completion but is adding an Associate of Applied Science Medical Assisting Degree which provides students additional skills and enhances their employability prospects and the ability to move into supervisory positions. The board will be asked to approve at the next board meeting.

J. STANDARD REPORTS

Personnel Report

Heather McDaniel, Interim Associate Vice President of Human Resources, said the report stands as written, noted there is one new hire, and acknowledged the retirees in the report and thanked them for their service.

Budget Status Reports

Aaron Hunter noted in the Statement of Resources and Expenditures that the tuition and fees number on the report is close to the final number for this fiscal year. On the Budget Status report, the general fund expenditures continue to be consistent with the previous year, the insurance line item is a net negative balance due to insurance premiums coming in higher at the beginning the year, and the maintenance line is showing a negative available balance due to several year-end projects that needed to be completed. On the Status of Investments, three investments matured and there are no new investments for the month. The Oregon Short-Term funds, LGIP, continue to have a rate increase from 3.75 percent to 4.05 percent.

Capital Projects Report

Aaron noted the HVAC projects will be completed by the end of June 30 and there are three sections of campus roadways that have new asphalt. Aaron thanked the Facilities team for its incredible work with the HVAC systems and other projects they have worked on. Jessica Howard thanked the staff for their tremendous amount of work and meeting the federal funds spend-by deadline.

Chemeketa Cooperative Regional Library Service (CCRLS) Report

Doug Yancey, Executive Director of Chemeketa Cooperative Regional Library Service (CCRLS) said the report stands as written. Doug said the fourth Network Administrator Recruitment did

not attract any candidates; however, the college is using an external consultant to fill the gaps. Ken Hector asked if feedback had been received from the candidates on reasons why they did not accept the position. Doug said pay was a critical factor and he is working with Human Resources to make the position more competitive.

President's Report

Jessica Howard noted this report is presented twice a year and stands as written, and highlighted a few items. The report covers OCCA, the Oregon Student Success Center, the HECC, the department of Community Colleges and Workforce Development, and the Oregon President's Council. Jessica mentioned the new state funding and distribution formula and how it is going to be allocated in the future, and provided an update on the Major Transfer Map work.

BUILDING 14 SEISMIC REHABILITATION ARCHITECTURAL SERVICES

A Request for Proposal (RFP) for the Building 14 Seismic Rehabilitation Architectural Services will be advertised on the college's Procurement Services Website, the OregonBuys Website, the Bid Locker Website, and in the Daily Journal of Commerce in July 2023. A recommendation for contract award will be submitted to the College Board of Education at its September 2023 meeting.

The college has received a \$1,407,180 grant from the Oregon Infrastructure Finance Authority of the Oregon Business Development Department to fund the seismic retrofit project. The intent of this solicitation is to secure an architectural firm to provide the design and engineering services required to address the structural and nonstructural deficiencies and the gravity load resisting system issues identified in the comprehensive Seismic Evaluation Report prepared by ZCS Engineering & Architecture in February of 2022.

Construction is tentatively scheduled to begin in June 2024 with final completion date of February 28, 2025.

The Computer Information Systems (CIS) program currently offers three certificates and two degree options. The three certificates, Systems Administration and Network Security Certificate of Completion, Computer Programming Certificate of Completion and Web Developer Certificate of Completion, are generally only awarded as part of completion of the Associate of Applied Science degrees.

The program, with input from the CIS Advisory Committee of industry partners, has determined there is a need for stackable, entry-level pathway certificates, as opposed to specialization certificates that are earned with the degree. Working with multiple other Oregon community colleges, the program is currently designing certificates with focus on introductory systems administration, certified secure computer-use, and computer programming.

Program faculty will work individually with currently enrolled students to facilitate certificate completion, either through curriculum substitutions, individual study, or offering limited sections with low enrollment.

It is recommended that the College Board of Education approve the suspensions of the Systems Administration and Network Security Certificate of Completion, Computer Programming Certificate of Completion and Web Developer Certificate of Completion.

The following changes have been made to the proposed new Law Enforcement degree:

- Adjust the former six-term, three-credit per program course to a seven-term, six-credit per program course.
- Remove course offerings that have duplicate information incorporated in them to adjust for the credit increase of the program courses.

It is recommended that the College Board of Education approve the suspension of the current Law Enforcement Associate of Applied Science degree and approve the new Law Enforcement Associate of Applied Science degree.

The Human Services department is proposing three main program changes:

- 1. Change program name from Human Services to Behavioral Health
- 2. Change prefixes for all courses from Human Services (HS) to Behavioral Health (BH)
- Collapse all three Associate of Applied Science degrees (Addiction Studies, Social Services, and Direct Support Professional) into one degree: Behavioral Health Associate of Applied Science degree

The proposed changes reflect the evolving health care perspectives and industry language. The redesign of the program creates flexibility, provides opportunity, and removes barriers for students.

Renaming the program "Behavioral Health" expands scholarship opportunities for students. Collapsing degrees into one allows course work to be the same across the program, providing students the option during their third term to focus on a specific area, as determined by their choice of practicum (see the term by term included in this report). These program changes also allow our students to qualify for the Qualified Mental Health Associate (QMHA) credential, which was recently adopted by the Mental Health Addiction Counselor Board (MHACBO).

As trained professionals, many of the students will move to supervisory and managerial positions that will impact behavioral health policy. These policy changes will allow our students to create cultures of community, belonging, and opportunity, which are Chemeketa values. The Behavioral Health Program fits within Chemeketa's vision as it focuses on a person-centered, strength-based approach for the individual students as parallel learning for students serving the community through their education. On a community level, the program places students with agencies that create positive change in different settings, services, and populations around the state.

In a larger context, this revised program fills employment gaps on state and national levels by training professionals for several underfilled positions in behavioral health. As there is both a national and a local push to target behavioral health, the program is well aligned in theory and practice with current legislation and perspectives surrounding the aforementioned issues.

The current Human Services degrees will continue in existing format until program changes have been approved by the state. Once the updated degrees are in place, a request to suspend current degrees will be presented to the Board.

It is recommended that the College Board of Education approve the previously stated changes.

The Medical Assisting program has been in existence since 2011 and has since graduated 500 students with the Medical Assisting Certificate of Completion. Adding an Associate of Applied Science (AAS) degree in Medical Assisting, provides Chemeketa students with a more comprehensive and in-depth education, enabling them to gain a deeper understanding of the medical field and enhance their employability prospects. Adding an AAS degree also allows previous Chemeketa graduates and future students to build upon the knowledge and skills gained through the Medical Assisting Certificate of Completion, which is fully encompassed within the AAS degree. The Medical Assisting program can accept up to 60 students per year.

Additionally, by offering an associate of applied science program, the program is responding to the growing demand for skilled medical assistants in the community, equipping graduates with the necessary skills and knowledge to succeed in this vital and rewarding profession. By introducing an additional pathway, individuals holding this associate degree can effortlessly bridge the gap and pursue Chemeketa's Bachelor of Applied Science (BAS) in Leadership and Management, thereby expanding their educational and career prospects. This change reflects Chemeketa's commitment to meeting the evolving needs of students and the community, and providing high-quality education and workforce training that positively impacts the lives and well-being of individuals and families.

The new degree is approved by both the Medical Assisting Advisory Committee and the Chemeketa Curriculum Committee. The advisory board is made up of clinical managers from all three counties in Chemeketa's service district.

It is recommended that the College Board of Education approve the Medical Assisting Associate of Applied Science degree.




