- Applications are reviewed, scored and ranked based on applicant-supplied information.
- Apprentices are selected from the ranked Pool of Eligibles (POE) based on points.
- Information for extra points may be added to the application until the closing date.
- Applicants receive a letter with the results of their application. Mandatory orientation is at 5 pm on January 30<sup>th</sup> in the Building 33 Apprenticeship Office on the Salem Chemeketa campus.
- Applications and materials cannot be returned.

The documentation you submit will be scored based on the criteria outlined below and then totaled. Your total score will determine your placement in the Pool of Eligibles (POE). In case of a tie, the earliest date of application will break the tie. Scoring will be based on the verifiable documentation you provide (letters on company letterhead from your employer(s), DD214, course certificates, school transcripts, etc.). Resumes are not acceptable for points for work experience, though may be included with the application.

4.	College, military & trade school degrees/certificates – 8 points per degree/completion/AAS degree.	8 Maximum
5.	Pre-apprenticeship - Youth Builders, Oregon Tradeswomen, Job Corps, and other OSATC approved programs.	4 Maximum

6.	Sheet metal related work experience – 2 points per six months, 8 points maximum All other construction work experience – 1 point per six months, up to 4 points maximum.	12 Maximum
7.	Military Service: 2 points per year of service with DD 214 with Honorable Discharge	8 Maximum
8.	Valid Driver's License	7 Points
9.	Certifications: First Aid/CPR, forklift operator, and other construction related.	5 Maximum
