## Health Information Management Program Information Overview

The Health Information Management (HIM) Program is a limited enrollment program designed for individuals interested in managing and organizing health data. Admission is competitive, with students selected through an application process to form a spring cohort of 35 students each year. There is a practicum component to this program. We offer an in house practicum experience however if the student chooses to complete a practicum experience in the field they may be responsible for finding their own placement.

Once accepted, students follow a structured, term-by-term advising plan to complete the program. This program is intensive and will require you to have the time and dedication to complete the courses. The HIM Program is a 9-month certificate program, offering focused, accelerated training in areas such as health data management, electronic health records, medical coding, and regulatory compliance. At the end of the program you will be eligible to sit for the certification exam through AAPC.

This program prepares students for roles that require attention to detail, data analysis, privacy awareness, and familiarity with healthcare systems. Graduates are typically employed in settings like hospitals, clinics, insurance companies, and public health agencies.

Important: Please review the program website carefully to understand the responsibilities and expectations of working in this field, as health information management involves handling sensitive data and adhering to legal and ethical standards in healthcare.

### Communication

All program communications will be sent to my.chemeketa.edu email. Students must check their email at least 3 times per week (daily recommended), including summer term.

### Program Cost

The Healthcare Coding Certificate Program at Chemeketa Community College requires 43 credit hours to complete. For the 2025–2026 academic year, the tuition and fees are as follows:

- Tuition per credit hour: \$111
- Universal fee per credit hour: \$39
- Total cost per credit hour: \$150
- Total cost: 43 credits × \$150 per credit = \$6,450

Please note that this estimate covers tuition and universal fees only. Additional expenses may include textbooks, course materials, lab fees, and other program-specific costs. For the most accurate and up-to-date information, please refer to the official program website or contact the college directly.

## **Criminal Background Check Requirement**

Accepted students must pass a criminal background check. Failure will result in dismissal. Students must notify the Program Chair of any arrests during enrollment. Additional background checks may be required for practicum placement.

## **Drug Screen Requirement**

Accepted students must pass a drug screening to continue in the program.

## **Immunization Requirements**

To participate in practicum placements, students must meet immunization requirements:

- TB Screening: Two-step skin test or QuantiFERON Gold blood draw
- MMR: Two doses or positive titer
- Varicella: Two doses, one dose before age 13, or positive titer (disease history not accepted)
- Hepatitis B: 3-dose vaccine or positive titer
- Tdap: Vaccine within the last 10 years
- Flu: Seasonal vaccine (due by October 1); Declination form accepted, but mask required
- COVID-19: Vaccine or declination/medical/religious exemption form

Immunizations requirements will be required to enter the program.
